

**YOUR AFTERNOON MADE BETTER WITH OLDTOWN & POLAR COLLABORATION  
FULL TERMS AND CONDITIONS**

These terms and conditions (the “**Terms**”) shall apply to the “**YOUR AFTERNOON MADE BETTER WITH OLDTOWN & POLAR COLLABORATION**” redemption organized by JACOBS DOUWE EGBERTS RTL SCC SG PTE LTD (the “**Company**”), (the “**Promotion**”).
